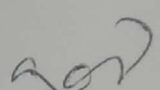
Terms and conditions:-

1. Pay will be Rs. 4900-10680+1300 GP plus other allowances as admissible under the rules notified by the Government from time to time subject to the conditions laid down in the rule and order governing the grant of such allowances.
2. The post is temporary and can be terminated at any time by one month notice from either side viz the appointee or appointing authority.
3. The appointee shall have to serve in any part of Himachal Pradesh.
4. He/ She will be on probation for a period of two years and if during this period his/ her services are not found satisfactory his/ her services can be terminated at any time without giving any notice.
5. Other condition of services will be governed by the relevant rules and orders of Govt. in force from time to time.
6. The appointment shall be further subject to the production of the following certificates/declaration:-
 - a. Character Certificate from Sub Divisonal Magistrate or any other Gazetted officer to whom the candidate is known for the last three years.
 - b. Attested copies of proof of his/her date of birth.

- c. Declaration to this effect that the appointee has not/ shall not have more than one living spouse.
- d. Taking an oath of allegiance/ faithfulness to the constitution of India or making solemn affirmation to the effect.
- e. Attested copies of educational qualification certificate, if available.
- f. An affidavit to the effect that he/ she is not a dismissed employee from the service of Govt. / Public Sector undertaking local bodies.
- G. Before joining, the appointee has to submit fitness certificate from the CMO of concerned District.

In case the above terms and conditions are acceptable to him/ her, he/she will report for duty at the place of posting, assigned by concerned District Ayurvedic Officer within 15 days of issue of these orders failing which the offer will be treated as cancelled.

Hence forth, 21 posts of daily waged Class-IV's/Sweepers shall stand abolished.

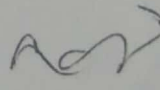
