OFFICE ORDER

In continuation to this Directorate office order No. Ay.H(F)(3)-7/85-Vol-II, (Incentive)-19275-91, dated 24/09/2024. In addition, as per the approval of the Executive Body of the State AYUSH Society, Himachal Pradesh, in its meeting held on 12.11.2024 held under the chairmanship of Secretary AYUSH, the following Performance Linked Indicators (PLIs) shall be applicable for the release of the monthly incentives to AMO-CHO posted in AYUSH Health & Wellness Centres in tribal areas :-

Further, it is also been approved by the Executive Body of the State Ayush Society that the Homoeopathic Health Centres upgraded to AYUSH Health & Wellness Centres shall also be eligible for CHOs/Team Based incentives, but only the procedures component per month fixed for Ayurvedic HWCs is replaced with allergy/specialty clinic in Homoeopathic treatment as under :-

The PLI which shall be payable to a particular AMO/HMO/CHO shall be calculated, proportionately to the performance as tabulated above. The AHWC shall maintain a complete record of the parameters based on which the PLI shall be admissible and the record shall be made available to any inspecting Officer. The Performance sheet of the AHWC shall be maintained by the SDAMO and the PLI shall be disbursed on the basis of this sheet only. The record of such performance sheets shall be maintained in the SDAMO Office.
