## Expression of Interest

Expression of Interest is hereby invited under sealed cover from the desirous and experienced agency/firms for installation, operationalization and maintenance of Digital X-Ray machines in imaging centre at Regional Ayurvedic Hospital Shimla ,DAO Kangra,Mandi,Kullu,Solan,Nahan and Hamirpur (07 Nos.) on PPP mode on the following terms and conditions: -

1. Rogi Kalyan Samiti of Concerned Hospital will provide vacant covered space including water and electricity connection to the selected agency. Water and electricity charges will be borne by the agency. In case the electricity connection has to be upgraded, the agency would be required to do the same.

2. The contract shall be awarded to the agency who would offer higher rate of share out of net profit. The minimum rate of share out of net profit to be offered would

be (a) 20%.

3. The applicant agency/firm should be compliant of AERB Norms and PNDT Act and registered with concerned regulatory authority and the applicant should ensure that all procedures staffing is as per established standard. The copies of related documents are required to be submitted with EOI.

4. The agency/firm will have to employ technical manpower as well as carry out all the necessary work for the establishment of the Digital X-ray plant in the proposed institution in consultation with the department. The agency will also recruit and train the necessary technicians/staff for operating and managing the machines and generating reports as per requirement/prescription of the physicians of concerned hospital.

5. The Agency/firm will have to install latest product introduced in India/globally within last 3 years. Before installation of the machines the agency will provide necessary documentary evidence (including an affidavit) of the total machines. Digital X-Ray machine installation will be given preference over computerised Radiography imaging.

6. The Agency/firm will have to provide Non-conviction certificate for the last three years submitting affidavit from Magistrate that they are not blacklisted by any

Govt. Department /Govt. organization.

7. Sub-contracting for any part or any setup would not be allowed. The agency/firm would have to report to the concerned Rogi Kalyan Samiti (RKS)the name, qualification, photograph and other relevant details of every personnel working in the proposed centre.

8. The agency/firm will be responsible for installing all necessary equipment with accessories as per requirement and also for operation and maintenance of the

digital x-ray equipment.

- 9. The rates for the x-ray to be charged from the patients of Ayurvedic Hospitals(Indoors and Outdoors) shall be equal to the rates charged by the said RKS.
- 10. The X-Ray lab services shall be provided from 09.30 A.M to 04.00 P.M on daily basis as per OPD timing of the Hospital and also shall be available even after the

OPD timings in emergent circumstances and option is open to entertain the prescription for X-ray from other physicians apart from the physicians of Ayurvedic Hospital.

11. The arrangement is proposed for ten years lease/agreement initially and will be extendable on an annual basis thereafter subject to the satisfactory performance of

the firm.

12. The applying agency/firm will have to deposit 25000/- (Twenty-Five Thousand) as earnest money in the shape of Demand Draft in favour of Director of Ayurveda, H.P,Shimla with the EOI and Earnest money of successful bidder will be retained as Performance Security.

13. The bidder shall also be required to submit the copies of PAN and Income Tax returns for last three Year alongwith copy of GST Registration, balance sheet for

last 2 years.

- 14. Technical bid consisting of all technical details alongwith commercial terms and conditions and financial bid shall be submitted separately. The Technical bid and the financial shall be sealed by the bidder in separate cover duly super-scribed. The Technical bid shall be opened in first instance and evaluated by committee and at the second stage financial bid only of the technically acceptable offers, shall be opened for the further evaluation and ranking before awarding the contract.
- 15. The successful agency/firm will have to enter into an agreement / MOU with the RKS concerned on the certain terms and conditions mutually agreed upon.

16. The agency will be free to have its own administrative system for management of its facility but it will have to take into consideration the advice and monitoring of operational activity from the competent authority of the RKS.

17. At the end of each month, within 5th day of the next month, the agency will be required to submit the activities and result areas for the preceding month to the concerned Rogi Kalyan Samiti (RKS).

18. Technical Presentation:- If deemed necessary, the applying agency/firm can be asked to make a power point presentation of its proposal to this department.

19. Rejection of EOI:- The department reserves the right to accept or reject any or all the offers at any stage of process without assigning any reason thereof and no claim or dispute on this aspect shall be entertained.

The sealed EOI document is required to be received in the Directorate of Ayurveda, on or before 3<sup>rd</sup> December 2018 up to 4.00 P.M. The envelope containing the EOI should be super scribed as "EOI FOR ESTABLISHMENT OF X-RAY PLANT". EOI received in time shall be opened on 04.12.2018 at 03.00 P.M. If the date fixed for receiving and opening of the EOI is declared a holiday, the EOI shall be received or opened on the next working day on the same time as fixed for the original date for this purpose.
